ABRIDGED FHBSC CONSTITUTION

Any person elected a member of a club ipso fact agrees to and shall be bound by the Constitution, Rules and further rules or by-laws that may be promulgated from time to time.

TITLE The name of the club shall be FISH HOEK BEACH SPORTS CLUB (FHBSC).

OBJECT: The object of the club shall be the encouragement and promotion of amateur sailing and other recreational water activities in all its branches.

MEMBERSHIP The membership of the club may be limited as to numbers and shall consist of:

- **FAMILY MEMBER:** Family membership shall be limited to an ordinary member, his or her spouse and children under the age of 18 years.
- **INDIVIDUAL MEMBER:** An individual member at the rate prescribed.
- **STUDENT MEMBER:** Bona fide student over the age of 18 years shall be entitled to membership at a reduced annual subscription
- **OTHER MEMBER:** Any other class of member as per the constitution amended from time to time by the members at the AGM

The election of Members shall be vested in the Committee who shall notify every candidate of his or her election.

PAYMENT OF SUBSCRIPTION all subscriptions are due on the 1st of August in each year. No member who has not paid his/her annual subscription by 31st October shall continue as a member and his or her name shall be posted on the club notice board.

RESIGNATION Any member wishing to resign from the club may do so provided he or she gives notice thereof to the Honorary Secretary and shall have paid his or her subscription for the current year.

CONDUCT OF MEMBERS If any member shall have been found by the Committee after due inquiries, to have been guilty of improper conduct, the Committee may by resolution expel such member from the club or suspend his or her membership for a period which it, in its discretion, deems fit and proper.

VISITORS A member's guest may participate in club activities on no more than **6 (six) occasions per annum**, and must be signed up in the visitor's book.

ANNUAL GENERAL MEETING The AGM of the Club shall be held in the month of June each year. A special agenda for the meetings shall be posted on the club notice board 14 days (fourteen) prior to the meeting.

PLEASE NOTE By failing to pay boat and/or surf ski rack parking for 3 (three) months or more, the member shall be deemed to have abandoned his or her boat and/or surf ski and grants FHBSC the right to dispose of such boat and/or surf ski, and offset the proceeds there from against unpaid rental, penalties and expenses, incurred by FHBSC .If you sell your boat and/or surf ski to someone who continues to keep such property at FHBSC ,you must advise the Treasurer or Secretary of the name and contact details of the new owner, or you will be invoiced for parking.
